1. I agree to respect adult leaders and other participants.
2. I will not leave my assignment unless my adult leader grants permission.
3. I agree to demonstrate Christian values by my language and behavior.
4. I agree not to possess any drugs, tobacco, alcohol, fireworks, matches, cigarette lighters, knives, or items that would endanger people, pets, wildlife, or property or are illegal.
5. I agree to dress appropriately. I will wear my Camp Guadalupe T-shirt daily with modest pants or shorts (short shorts are prohibited). I will wear a modest bathing suit (one piece for girls) on Water Day, if applicable.
